# Annual General Meeting

Keep your calendar open for the Gordon Woods Homeowners Association Annual General Meeting tentatively scheduled for December 1 in the Noel Ryan Auditorium in the Central Library. The date is subject to a potential conflict with a public meeting by City Hall on the same day (see below).



## **Development Update**

Win-Win for Grange/Harborn/Premium Way Remember the 21-unit townhouse proposal that Berkley Homes was proposing for Grange Drive, Harborn Road and Premium Way? Well, over the summer thanks to the hard work and constructive comments given by a group of Gordon Woods' residents, it is now an 18-unit proposal that includes a mix of singles and townhouses. The current proposal for Harborn Road has 4 singles. On Grange the proposal is for 7 units. Six of these are semi-detached that look like singles and the seventh is a single. For Premium Way the proposal remains as 7 townhouse units. Given that the site is in the Hurontario intensification zone and portions either abut the Rabba plaza or face a major highway intersection, we feel that this is a winwin compromise that provides a suitable transition from the Hurontario corridor to Gordon Woods. Berkley Homes plans to construct the most westerly home on Harborn Road next Spring and use that as a model home and sales office for the entire development. This means no portable sales trailer! However, the construction of the model home requires a minor variance from the Committee of Adjustment that should be heard in late fall. In addition, the entire development is to be reviewed at a public meeting at Planning Committee. More information on this meeting will follow.

#### Proposed Subdivision - 2167 Gordon Drive

The remaining issue with this proposal that will see four additional homes constructed at 2167 Gordon Drive on a private roadway is to determine whether natural drainage can be used instead of a storm sewer. This would result in less tree loss and be more compatible with the 'rural-like' character of Gordon Woods. Some engineering studies have been conducted and are now being analyzed. The second public meeting will likely take place early in the new vear.



### **Gypsy Moths**

There was definite evidence of increased Gypsy Moth activity in Gordon Woods this past summer. To help reduce next year's population, please inspect your property for egg masses. A great time to find, remove and destroy them is while doing your fall clean-up. The masses can be the size of a quarter to a loonie, are light brown in colour (see photo below) and may be found on any surface. A single egg mass can hold up to 1,000 eggs. Scrape them off into a container of soapy water and discard after a week or two. If left to overwinter, caterpillars will hatch out in spring.
