Heritage Trees

The GWHA has submitted a letter to City Council to reconsider our recommendation to protect single heritage trees. While the recently amended Private Tree By-law has taken steps to reduce the number of trees that can be cut per year, it does nothing to protect single, majestic heritage trees. Without that protection and with indiscriminate property development, ongoing removal of canopy tree species result in: increased air and noise pollution, higher temperatures and wind affects, changes in moisture (soil and air), loss of habitat, wildlife and native vegetation – all significant factors that are undeniably necessary to sustain any woodlands environment. And in addition to the scientific facts, protection and preservation of mature, majestic, heritage trees should be first and foremost to foster our quality of life. It's incumbent on all of us to encourage and practice good stewardship to preserve this unique neighborhood.



There was definite evidence of increased Gypsy Moth activity in Gordon Woods this year. The Forestry division continues to monitor the gypsy moth populations throughout the City. The Ministry of Natural Resources reports that due to a very wet and cool spring, the natural pathogens are very present this year (E. maimaiga & NPV) which has resulted in very high mortality rates in caterpillars. Although some trees appear to have had high numbers of caterpillars, the majority of them were dead, which means they will not being laying egg masses for next year, and that nature really is taking its course. As of now, the City doesn't anticipate having issues next year that require an aerial spray program.

To coordinate an aerial spray requires a number of permissions and permits required from Municipal, Provincial and Federal agencies, namely Transport Canada, Ministry of the Environment, Ministry of Transportation, Peel Police, OPP, Mississauga Transit and Region of Peel. For a community such as Gordon Woods to conduct our own spray program would be a huge challenge and very costly.

How can you help reduce next year's caterpillar population? Please inspect your property for egg masses. A great time to find, remove and destroy them is while doing your fall clean-up, i.e. now! If the eggs are left to over-winter, caterpillars will hatch out in spring, morph into moths that lay more eggs. The egg masses can be the size of a quarter to a loonie, are light brown in colour (see photo below) and may be found on **any** surface. A single egg mass can hold up to 1,000 eggs. Carefully scrape the egg masses off into a container of soapy water and after a week or two, discard with your trash or food waste. For more info, contact Shelly at 905-272-3484 or visit

2167 Gordon Dr – On June 26, 2013 the owner of this property had 2 healthy 150 year old oak trees, each over 100 cm in diameter, cut down – even though the development proposal for this property is currently before the City Planning department and under review. The owner has made application to the Committee of Adjustment to sever the property – one lot with a frontage of 98' and the other with a 68' frontage. The hearing is scheduled for September 26.

2100 Parker Dr – The property owner submitted an application to the Committee of Adjustment requesting a number of variances to permit the construction of a new home. Many of the variances are more than double that which is permitted under By-law. The GWHA submitted a letter of objection however the Committee approved the application.
